Grandefield Homeowners Association reserves the right to use the Property in any manner not inconsistent the use rights granted herein.
- 2. <u>Term.</u> The term of this Waiver shall commence on December ___, 2018, and shall terminate on January ___, 2019 ("<u>Term</u>"), unless earlier terminated as a result of a violation by Licensee of any provision of this Waiver.
- 3. <u>Personal Nature of Use Rights</u> This use rights granted under this Waiver are personal to the Resident. Such rights are not assignable, and any attempt to assign such rights will terminate this Waiver.
- 4. <u>Right to Terminate</u>: Grandefield Homeowners Association reserves the right to terminate this Waiver in the event of any violation by Resident of any provision of this Waiver.
- 5. <u>Compliance with Law, Rules and Regulations</u>: Resident shall comply with all applicable laws, rules, ordinances and other legal requirements applicable to Resident's use of the Property. In the exercise of its rights hereunder, Resident shall not interfere with or impede the use and enjoyment of any portion of the Grandefield at Poley Creek Homeowners Association by any other person or entity.
- 6. <u>Liability and Indemnification</u>.
